ISO 22301 Business Continuity Management System

Course Introduction

Implementing a strong Business Continuity Management System (BCMS) will aid the organisation in quickly recovering from a disaster or disruption. The business BCM standard can also safeguard an organisation against the proceeding reputational damage which can occur from missed deadlines, data leakages, operational or IT outages, industrial actions, disappointed clients or direct financial losses due to the disruption. The key concepts of business continuity will be discussed in this course to help in understanding the benefits of a business continuity management system and being familiar with the requirements of ISO 22301
